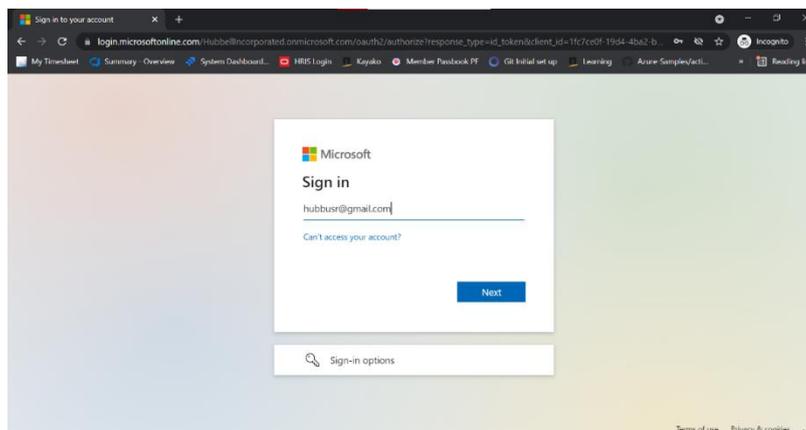

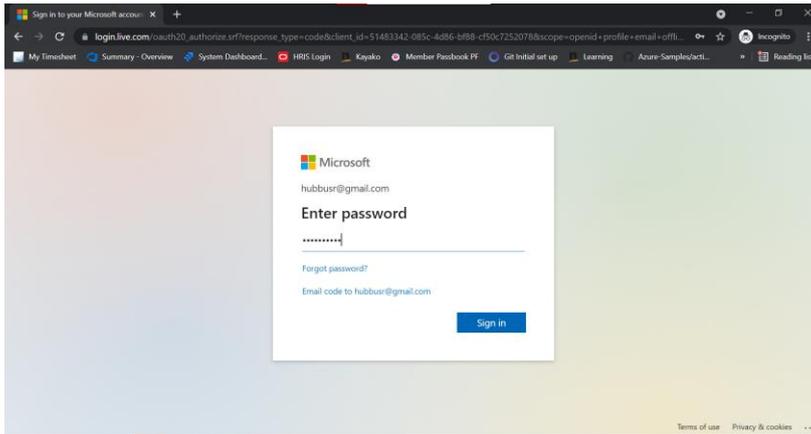

STEP 3

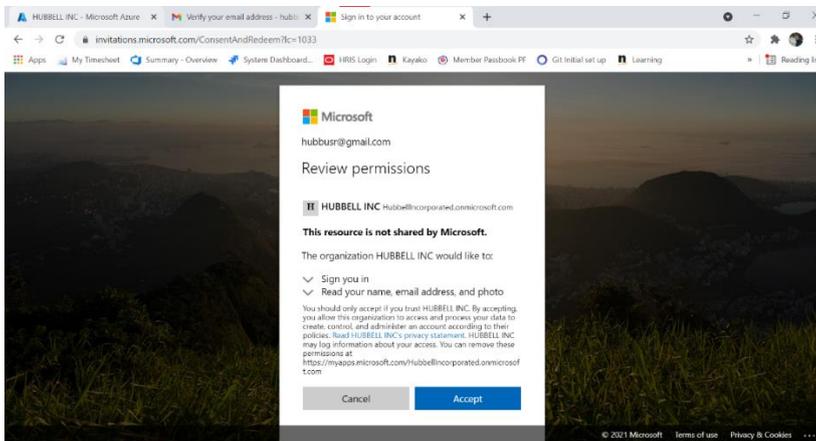
Once you click on the link you will be navigated to the Login Screen. You will be required to login with your email id used earlier on Submittal Tool platform.



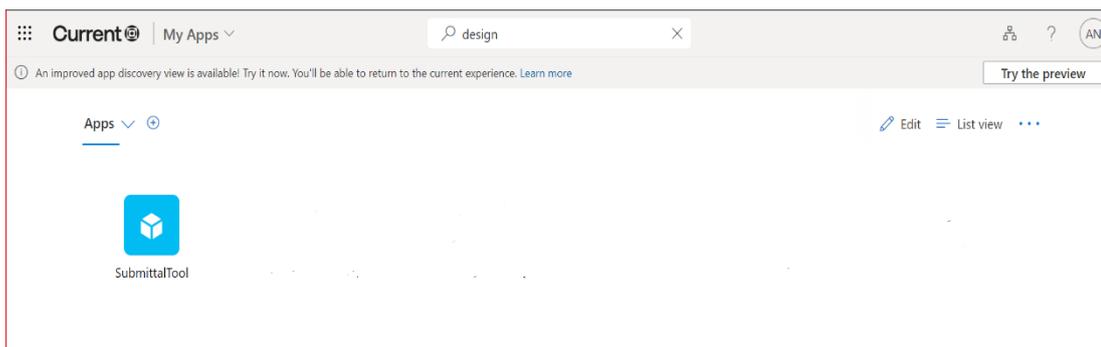


STEP 4

After successfully logging in: Accept the permissions.

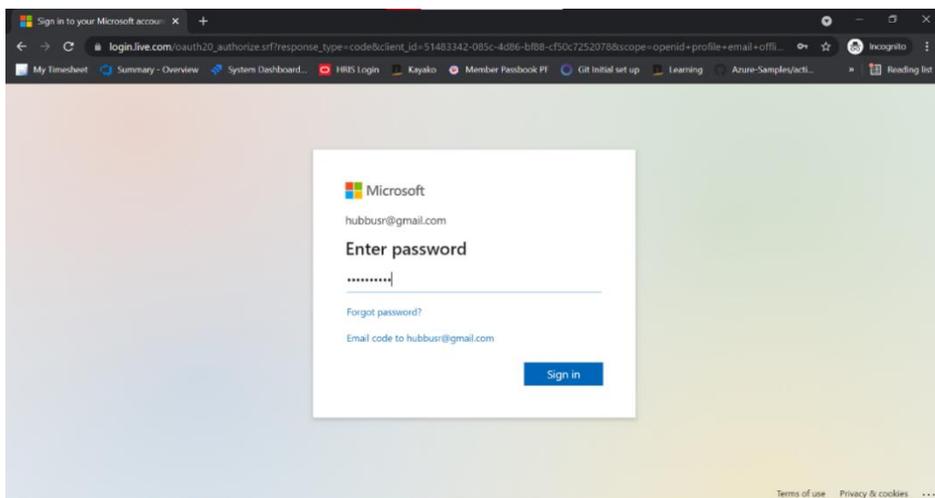
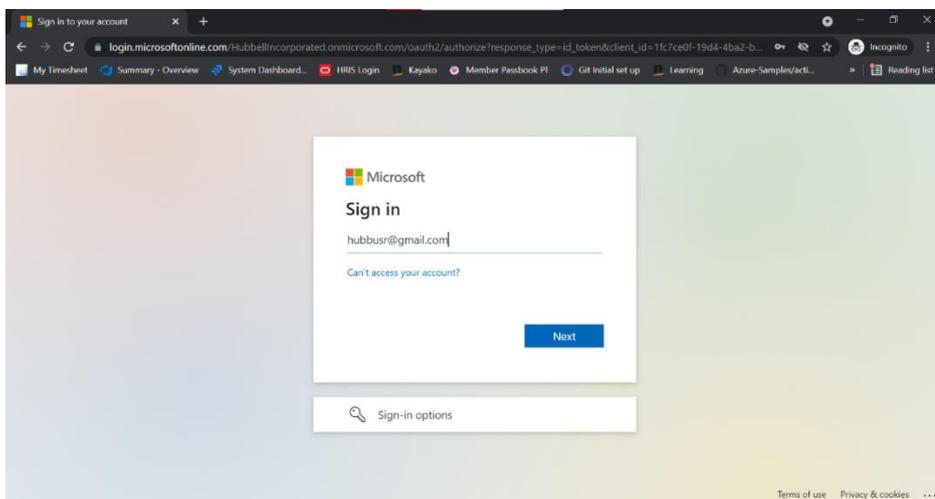
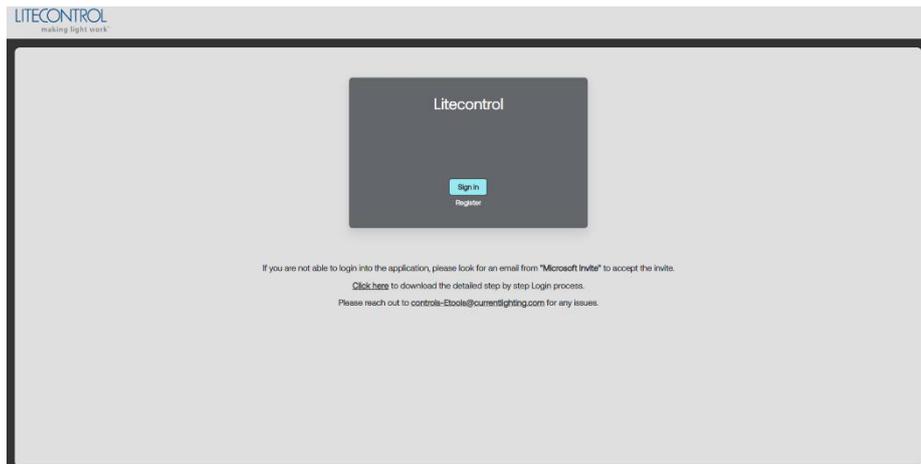


You will be shown link to the Submittal Tool application.
